NON-DISCLOSURE AGREEMENT

This Non-Disclosure Agreement ("Agreement") is entered into as of _____ ("Effective Date") by and between **Open Frame Productions and/or** _____ [FILM LLC NAME] ("Company") and _____ [INDIVIDUAL OR ENTITY NAME] ("Recipient").

1. PURPOSE

Recipient may receive confidential, proprietary, or non-public information relating to Company's business operations, motion picture projects, creative materials, financial information, production plans, investor materials, or related matters (collectively, "Confidential Information"). This Agreement governs Recipient's use of such information.

2. CONFIDENTIAL INFORMATION

"Confidential Information" includes, without limitation:

- scripts, treatments, outlines, and story concepts
- pitch decks, business plans, budgets, and financial data
- investor information and deal terms
- production schedules, locations, and logistics
- cast, crew, and vendor information
- any non-public information disclosed orally, visually, or in writing

Confidential Information does not include information that:

- is publicly available through no fault of Recipient
- is independently developed by Recipient without reference to Confidential Information
- is lawfully obtained from a third party without restriction

3. OBLIGATIONS OF RECIPIENT

Recipient agrees to:

- use Confidential Information solely for the intended evaluation or business purpose
- not disclose Confidential Information to any third party without prior written consent
- take reasonable measures to protect Confidential Information

Recipient may disclose Confidential Information only to advisors who are bound by confidentiality obligations at least as protective as those herein.

4. NO LICENSE OR OWNERSHIP

Nothing in this Agreement grants Recipient any ownership interest, license, or rights in Company's intellectual property, projects, or business.

5. NO OBLIGATION

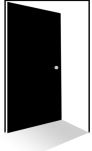
This Agreement does not obligate either party to enter into any business transaction, investment, or creative relationship.

6. RETURN OR DESTRUCTION

Upon Company's request, Recipient shall promptly return or destroy all Confidential Information in Recipient's possession.

7. INJUNCTIVE RELIEF

Recipient acknowledges that unauthorized disclosure may cause irreparable harm. Company shall be entitled to injunctive relief in addition to any other remedies available at law or equity.
